



## LPDC Guidelines and Fees for Educators Not Currently Employed

With the passage of House Bill 438, effective Sept. 28, 2018, Individuals who are licensed by the Ohio Department of Education and are either 1) not currently employed as an educator or 2) not currently employed by an entity that offers them a Local Professional Development Committee may work to renew their licenses through a cooperating educational service center's Local Professional Development Committee(LPDC).

The Educational Service Center of Lake Erie West's Local Professional Development Committee (LPDC) is pleased to welcome 1) all educators not currently employed by a school/school district or 2) not currently employed by an entity that offers them a Local Professional Development Committee.

The registration fee associated the services of the ESC of Lake Erie West's LPDC is \$100.00 per five-year license cycle and is non-refundable. The fee must be paid prior to the LPDC processing the Individual Professional Development Plan (IPDP). In order to begin accruing professional development hours, the IPDP must first be approved by the ESC of Lake Erie West's LPDC. **Any activities completed prior to the IPDP being approved cannot be accepted unless the educator has an Approval Verification Form from a prior LPDC or they have a valid reason to appeal.**

By agreeing to work with the ESC of Lake Erie West's LPDC, the educator agrees to the policies and procedures set forth in the ESC of Lake Erie West's LPDC Handbook, which is located at <http://www.eslakeeriewest.org/LPDCHandbook.aspx>.
