

STUDENT CONTRACT

Should a student not have this signed contract on file, they will lose their opportunity for a warning and have their cell phone privilege revoked for the remainder of the school year.

Maintaining the integrity of the learning environment is the top priority

- Students will be permitted to have MP3/iPod in their possession throughout the school day **IF AND ONLY IF THEY ARE ON LEVEL 3 OF THE SCHOOL LEVEL SYSTEM OR ABOVE.**
- Students may only use listening devices after getting teacher permission during non-instructional time. **NO LISTENING DEVICES ARE PERMITTED IN HALLWAYS OR RESTROOMS.**
- Students **MUST** have their cell phone and listening devices turned **OFF** upon entering the school building. **NO EXCEPTIONS.**
- Students **MUST** turn their cell phones and listening devices into their homeroom teacher upon entering the classroom.
- During the expressed time when cell phones are allowed to be on and in use, students are encouraged to keep their phone on "silent" mode, should that option be available.

Should a student be observed using a cell phone, or a cell phone is found during the school day, discipline will include but it not limited to, confiscation of the phone. Additionally, student abuse of this policy will result in the student losing the privilege to be able to bring a cell phone to school, or for a period of time as determined by the administrator.

- Student behavior concerning listening devices or cell phones must be consistent with the Technology and Internet Acceptable Use Guidelines.
- Student cell phone or listening devices found during the school day without permission, will result in confiscation of the phone and disciplinary action.
- Should confiscation occur, the phone will only be returned when retrieved by a parent or guardian (See ALC Handbook).

During times of testing and other student evaluations, teachers may request the students remove their listening devices from their possession and locking them in the homeroom lock box reducing the possibility of compromised test security.

Fire drills, assemblies, or other school evacuations are considered cell phone blockouts. During such contingencies, there, there will be absolute **ZERO TOLERANCE**, for cell phone use.
